Grantee Highlight

Partnership Achieve: E.L. Haynes and Mary's Center

- **Location:** Ward 4; Georgia Avenue Campus (MS) and Kansas Avenue Campus (ES and HS)
- **Grades served:** ES - Pre-K 3 through grade 4; MS – grade 5 through 8; HS – grade 9 through 12
- **Student population (as of 2014-15 school year):**
 - ES - Approximately 358 students; Approximately 43.9 percent African American; 36.6 percent Hispanic/Latino; 14.5 percent White Non-Hispanic; 4.7 percent Multiracial; and .3 percent Asian; 68.4 percent Economically Disadvantaged
 - MS - Approximately 377 students; Approximately 46.2 percent African American; 42.7 percent Hispanic/Latino; 5 percent White Non-Hispanic; 4.5 percent Multiracial; 1.3 percent Asian; and .3 percent Native American/Alaska Native; 75.9 percent Economically Disadvantaged
 - HS – Approximately 422; Approximately 53.8 percent African American; 42.7 percent Hispanic/Latino; 1.7 percent Multiracial; .9 percent Asian; .5 percent White Non-Hispanic; and .5 percent Native American; 68.7 percent Economically Disadvantaged
