Independent Accountant's Report

We have examined the accompanying Schedules of Student Enrollment and Nonresident Tuition Assessed for the District of Columbia Public Schools (DCPS) and Public Charter Schools (PCS) as of October 5, 2012, as required by DC Code 38-1804.02. The District of Columbia Office of the State Superintendent of Education (OSSE) is responsible for the accompanying schedules. Officials of DCPS and each public charter school are responsible for the enrollment data supporting the accompanying schedules. DCPS and PCS officials did not provide us written assertions about their enrollment data. Our responsibility is to express an opinion as to the accuracy of the enrollment count reported based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and, accordingly, included examining, on a test basis, evidence supporting the Schedules of Student Enrollment and Nonresident Tuition Assessed and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

Basis for Qualified Opinion

Our examination included of a physical head count of the general education enrollment population of the District of Columbia public schools, as well as procedures for District of Columbia students enrolled in non-public schools, programs and surrounding county schools. In addition to the physical count, our examination consisted of a review of student records to determine enrollment and residency status as of October 5th of the current school year. The student enrollment data was provided by OSSE and was comprised 84,421 students as detailed below:

- 80,854 general education students as indicated on the October 5th Statewide Longitudinal Education Database (SLED)
- 3,567 District of Columbia students enrolled by DCPS, PCS, OSSE and DC Child and Family Services Agency (CFSA) in non-public schools, programs and surrounding schools.

The enrollment discrepancies attributable to the general education population were 1%; however, the enrollment discrepancies for the students placed by DCPS, PCS and OSSE were 26% and for CFSA placed students, the discrepancy rate was 87%. Our examination disclosed the following deficiencies in student records that resulted in material misstatement of the enrollment data.

Review of Examination Results for General Education Enrollment

As indicated on the Schedule of Student Enrollment for DCPS and PCS, OSSE reported 80,854 students were enrolled in the general education program. Our examination determined 80,231 students to be enrolled. The primary basis for the net 623 variance in the number of students who were determined to be enrolled at a school related to:

- Duplicate student enrollment
- Non-attending and withdrawn students
- New enrollment

1. *Duplicate student enrollment.* Our examination disclosed 220 duplicate enrollments as of October 5th. A duplicate enrollment occurs when a student has been reported as enrolled at more than one school. Each Local Education Agency (LEA) uses a separate student information system for tracking and reporting enrollment. Because there is no consolidated student information system used to enroll and track all District students, it is possible for a student to be recorded as enrolled in more than one LEA. OSSE issued guidance related to the resolution for duplicate student status in its Absent Student Documentation and Hierarchy (Policy) and this guidance was utilized in our procedures to determine which school would be credited for a student.

2. *Non-attending and withdrawn students.* There were 506 students classified as non-attending or withdrawn during our examination and excluded from the enrollment. OSSE provided guidance in its Absent Student Documentation and Hierarchy (Policy) for determining enrollment status for students who were absent on count day. If such criteria were not met, a student was to be classified as non-attending. The OSSE criteria for determining absent student enrollment as of October 5th was

- An attendance record for a student had to reflect attendance during the period September 24th through October 19th. If attendance records were not available then acceptable documentation could be one of the following:
- A parent or guardian note regarding the absence
- Classwork reflective for the above mentioned period

Students, who were reported as withdrawn by schools as of October 5th yet still reflected in the OSSE database, were considered not enrolled for purposes of our report.

3. *New enrollments.* The results of our examination identified 103 students who were found to be attending DCPS or PCS schools as of October 5th but not included in SLED data provided for testing. We both physically counted these students during our examination and inspected student records to ascertain enrollment and residency status as of October 5th.

Review of the DC Residency Verification Form and other appropriate documentation.

Of the 80,231 students determined to be validly enrolled in DCPS or PCS schools, 80,138 students were categorized as residents of the District of Columbia. Compliance with OSSE guidance requires schools to maintain residency supporting documentation for all enrolled students. For each student, our procedures included a review of the DC Residency Verification Form or any other appropriate alternative residency document, as specified by OSSE guidelines. Additionally, our procedures included an inspection and assessment of residency supporting documentation for a randomly selected sample of the student population at each school. Based on our examination, there were 92 students attending DCPS or PCS schools for whom a Residency Verification Form or other OSSE approved residency documents were not provided or for whom the supporting residency documentation provided by the schools were not in compliance with OSSE guidelines.

Examination Results for Students Attending Non-Public Schools, Programs and Surrounding County Schools

The Schedule of Student Enrollment reflects 3,567 students reported by OSSE as enrolled in nonpublic schools, programs and surrounding county schools. The composition of the 3,567 enrolled students is highlighted below:

1. 1,968 students placed by DCPS, PCS or OSSE
2. 1,538 labeled by CFSA (wards of the District of Columbia).
3. 61 incarcerated youth at a county facility which were not part of the general education student population

This examination verified only 1,691 students attending non-public school, programs and surrounding county schools. Of that total, it was determined that there were 1,433 students placed by DCPS, PCS and OSSE, and 317 students placed by CFSA and 59 incarcerated youth. The 1,433 student tally includes 118 students who are wards of the District of Columbia. Similarly to the general enrollment audit results, the foremost reason for the 1,876 student variance relates to duplicate enrollments in the database and non-attending and withdrawn students. There are 160 students for whom a Residency Verification Form or other OSSE approved residency documents were not provided or for whom the supporting residency documentation provided by the schools was not in compliance with OSSE guidelines.

Opinion

In our opinion, except for the material misstatements described in the preceding paragraphs, the schedules referred to above present, in all material respects, the total number of resident students enrolled as of October 5, 2012, based on criteria described in Note 1.

Other Matter

Our examination was conducted for the purpose of forming an opinion on the accompanying Schedules of Student Enrollment and Nonresident Tuition Assessed. The schedules shown as Attachments A through F are presented for purposes of additional analysis and are not required

schedules under DC Code 38-1804.02. The information in such schedules has been subjected to the examination procedures applied in the examination of the Schedule of Student Enrollment, and, in our opinion, except for the effects of the misstatements described in the preceding paragraphs, such information is fairly stated in all material respects in relation to the Schedule of Student Enrollment. In addition, we noted other matters that we have reported to OSSE in a separate letter dated January 23, 2013.

Restriction on Use of Report

This report is intended solely for the information and use of the District of Columbia Office of the State Superintendent of Education, Office of the Mayor, City Council, DCPS Chancellor's Office, and the Public Charter School Board and is not intended to be, and should not be, used by anyone other than these specified parties.

NOTE 1 - CRITERIA

DC Code 38-1804.02 requires an annual reporting by the Office of the State Superintendent of Education (OSSE) of student enrollment as of October 5th each year. The Schedule of Student Enrollment presents the enrollment calculations required by DC Code 38-1804.02, which includes students attending District of Columbia Public Schools (DCPS) and DC Public Charter Schools (PCS); students placed in nonpublic schools, programs and surrounding county schools for special education services by DCPS, OSSE, or a PCS; and students placed by the District of Columbia Child and Family Services Agency (CFSA) in nonpublic and surrounding county schools.

DC Code Section 38-309 requires that documentation be provided when enrolling a student to verify that the student is a resident of the District of Columbia. Such verification is required no earlier than April 1 each year in order for a student to be considered properly enrolled. OSSE has issued instructions to the schools as to the documents necessary to verify residency. The amounts of tuition assessed and collected for nonresident students were provided by the DCPS Office of Residency and charter schools with nonresident students.

Enrollment and Residency

Assessment of the accuracy of the enrollment reported by OSSE was based on (1) documents prepared internally by each school which were not subject to audit verification; (2) requirements as stated in OSSE's Enrollment Audit Handbook; and (3) OSSE's Absent Student Documentation and Hierarchy (Policy) which is further described in Note 3.

For the purposes of residency verification, review for the DC Residency Verification Form or other OSSE designated appropriate alternative document(s) provided by the schools was performed for each student. In addition, the supporting residency documentation was examined for a random sample of students at each school location for the school's adherence to DC Code Section 38-309 and OSSE guidelines.

Grade Level

Verification of the grade level for each student was not included in the examination procedures. The grade levels were reported as provided in the October 5th SLED or as appealed by the schools with the following exceptions. Students in special education schools and alternative programs are shown in the reports as "UN"-Ungraded; a few certain students with no grade levels noted were adjusted to a grade level based upon age ranges provided by OSSE, and students in the DCPS STAY programs were all shown as "AO"-Adult.

NOTE 2 - OSSE APPEALS PROCESS

OSSE has established a process whereby schools had the opportunity to appeal the decisions noted during the field examination. This appeals process, after the conclusion of the field examination, allowed LEAs to present additional documentation for determination of enrollment, residency and grade level for students. The outcomes of the appeals process have been included in the enrollment audit results.

NOTE 3 - OSSE CRITERIA FOR DUPLICATE AND ABSENT STUDENTS

For purposes of this examination, the following criteria were used for determination of enrollment.

- A present student on the day of the count was an enrolled student for the school if (1) the student was reported on the school's roster in the October 5th SLED and (2) there was only one school claiming the student (not a duplicate student enrollment).
- A student who was present on the day of the enrollment count yet not reported on the school's roster in SLED as of October 5th was an enrolled student for that school if (1) acceptable documentation for enrollment at October 5th was provided during the examination and (2) no other school reported the student as enrolled (not a duplicate student enrollment).
- For a student being claimed by multiple schools as an enrolled student (duplicate student enrollment), OSSE's criteria as outlined in the Absent Student Documentation and Hierarchy (Policy) stated that the school receiving credit for the student would be the school at which the student had most days of attendance for the period September 24th through October 19th. In cases of a tie in the number of days attended, the school that the student attended on October 5th received credit for enrollment.
- For a student who was absent on the day of the count, the OSSE criteria as outlined in the Absent Student Documentation and Hierarchy (Policy), stated that the school could provide:
- Attendance records for a student to reflect attendance during the period September 24th through October 19th. If attendance records were not available, then acceptable documentation could be
- A note from parent/legal/doctor if absence on count day was because of an illness, court-ordered appearance, out-of-school suspension, etc.; or
- Two pieces of the student's school work/exam documentation during the period September 24th through October 19th.
